1. **National Letter of Intent update.** Susan Peal, Director of Governance and Policy, and Keith Gill, Sun Belt Conference, provided an update on the recent the National Letter of Intent (NLI) survey conducted by the Conference Commissioners Association.  
  
The NLI Policy and Review Committee developed a recommendation that the CCA establish a two-year pilot program that would adjust the Football Bowl Subdivision (FBS) and Football Championship Subdivision (FCS) early signing period. The FBSOC reviewed the two-year pilot program concept and will continue discussions at a future meeting as part of the ongoing review of the recruiting calendar.
