

REPORT OF THE NCAA DIVISION I FOOTBALL BOWL SUBDIVISION OVERSIGHT COMMITTEE NOVEMBER 7, 2024, VIDEOCONFERENCE

ACTION ITEMS.

INFORMATIONAL ITEMS.

- 1. Request to amend maximum institutional official visit limitation for Football (FBS). The committee continued their discussion of a request to amend football's official visit legislation. The committee directed the staff to approve a blanket waiver to allow institutions to provide an unlimited number of official visits in bowl subdivision football over the period of April 1, 2024, through March 31, 2025. The committee will discuss legislative solutions in a future meeting.
- 2. Playing and Practice Season Subgroup update. The committee received an update from the subgroup's October videoconferences. The committee discussed feedback from the FBS conferences regarding the first contest date and will continue the discussion in December. Feedback was provided on behalf of the College Football Playoff (CFP) management committee, which has requested time to develop and provide feedback before the FBSOC finalizes a recommendation. Additionally, the subgroup plans to discuss spring football and summer athletic activities during future videoconferences.
- 3. Request to exempt a contest from the maximum annual contest limitations. The committee continued their review of a request to establish the football contest between the United States Military Academy and the United States Naval Academy as an annual exemption. The committee was informed that the CFP Board of Managers will review this item at its January meeting and provide feedback to the FBSOC.
- 4. Update on 2024-25 FBS postseason deserving teams. The committee received an update on postseason bowl games and was reminded of the committee's responsibility for NCAA legislation in this area (e.g., deserving team status). The FBS members of the Football Oversight Committee's administrative committee will assist with any urgent requests, as needed.
- 5. NCAA Division I Football Student-Athlete Connection Group. The committee received an update from the November 3 FSACG videoconference. During that videoconference, the FSACG discussed the first contest date concepts and playing season legislation. They also received a demonstration of the NCAA NIL Assist application. The connection group's next meeting is on December 1.
- **6. NCAA Division I governance update.** The committee received an update on the NCAA Division I October 8-9 NCAA Division I Council meeting and future governance meetings.
- **7. NCAA legal issues update.** The committee received a legal update from the NCAA Office of Legal Affairs.
