#### <u>INFORMATIONAL ITEMS</u>.

- 1. National Football League Draft declaration dates. The committee received an update regarding declaration dates for underclassmen to ensure adequate time for the all-star games to set rosters. Later this fall, the NFL will distribute a memorandum to football institutions that identifies the agreed upon declaration deadlines between the league and the NFL Players Association.
- 2. Review request for exempt contest legislation. The committee received an update on a conference request for legislation to annually exempt the contest between the U.S. Military Academy (Army) and the U.S. Naval Academy (Navy), which has historically been played in December after the selection of participants for postseason bowls and the College Football Playoff. The committee agreed to discuss the request during a future meeting.
- **3. College Football Playoff update.** Richard Clark, executive director of the College Football Playoff, provided an update on the work of the CFP.
- 4. NCAA Division I Football Student-Athlete Connection Group update. The committee received an update from the September 15 FSACG videoconference. During the videoconference, the FSACG discussed the notification of transfer window concepts, the playing season subgroup and use of technology during contests. The connection group will meet again on October 20.
- **5. NCAA Division I governance update.** The committee received an update on upcoming Division I governance meetings.
- 6. Review of the FBS tryout and camps/clinic legislation and flag football. The committee did not discuss this item. It will be added to a future agenda.
- **7. Football Playing Rules update.** The committee agreed to receive this update during a future meeting.
- **8. FCS to FBS reclassification update.** The committee agreed to receive this update during a future meeting.
