# REPORT OF THE NCAA DIVISION I FOOTBALL CHAMPIONSHIP SUBDIVISION OVERSIGHT COMMITTEE MAY 5, 2025, VIDEOCONFERENCE

#### **ACTION ITEMS.**

- Legislative item.
  - Amend Football Championship Subdivision (FCS) institutional and studentathlete maximum contests legislation and first permissible contest date.
    - (1) <u>Recommendation</u>. The Football Championship Subdivision Oversight Committee recommends that the NCAA Division I Council adopt expedited legislation, for championship subdivision football, to amend the playing seasons legislation, as follows:
      - (a) Increase the institutional and student-athletes maximum contest limitations in any one year from 11 to 12 contests.
      - (b) Amend the FCS first contest date legislation to permit an institution to engage in outside competition beginning the Thursday 13 weeks prior to the selection of the NCAA Division I Football Championship participants; and,
      - (c) Eliminate all first contest date exceptions.
    - (2) Effective date. August 1, 2026.
    - (3) Rationale. In championship subdivision football (FCS), to standardize the football playing season each year to begin 13 weeks prior the FCS Championship selection date. This proposal also provides the opportunity for institutions to compete in 12 contests within a fixed 13-week period, providing consistency and, in years that would otherwise permit only 11 contests, additional scheduling flexibility.
    - (4) Estimated budget impact. Varied based on institutional decision-making.
    - (5) <u>Student-athlete impact</u>. Standardizing the start date and number of contests in FCS football enhances the overall experience and provides FCS football student-athletes with the opportunity to participate in the same number of regular-season contests as FBS football student-athletes, regardless of the calendar year. There is also time associated with preparing for and participating in an additional contest.
