NCAA DIVISION I FOOTBALL CHAMPIONSHIP SUBDIVISION OVERSIGHT COMMITTEE  
SEPTEMBER 13, 2023, VIDEOCONFERENCE**

**INFORMATIONAL ITEMS.**

1. **Notification of Transfer Windows Discussion.** The Football Championship Subdivision Oversight Committee discussed NCAA Division I Proposal No. 2023-36 (RECRUITING AND ACADEMIC ELIGIBILITY -- NOTIFICATION OF TRANSFER WINDOWS -- REDUCE FROM 60 DAYS TO 30 DAYS).

The committee expressed initial support for a football championship subdivision transfer window model that:

- a. Establishes a uniform application of transfer windows in Division I football (FBS, FCS);
  - The committee noted the Football Bowl Subdivision Oversight Committee indicated initial support for establishing a start date in football for the written notification of transfer process to begin the Monday following the second Saturday in December (Monday following FBS conference championship weekend);
- b. Considers the impact of the early National Letter of Intent signing period; and,
- c. Consists of three segments (December, January, April).

The FCSOC recognized the combined impact of: (1) The date of the last regular-season contest for many FCS institutions and FBS conference championships; (2) Notification of transfer windows; (3) The National Letter of Intent signing periods; (4) Head coaching changes; (5) Variations in academic calendars; and (6) The one-time transfer exception, on the recruiting process.

The committee agreed to solicit feedback from their respective constituents before the October 2-3, 2023, in-person meeting and expects to finalize a recommendation to the Council during those meetings.

2. **Approve NCAA Division I Football Oversight Committee July 20, 2023, report.** The NCAA Division I Football Championship Subdivision Oversight Committee approved the July 20, 2023, report.
