INFORMATIONAL ITEMS.

1. **Review of Proposals in the January 2025 Legislative Cycle.** The NCAA Division I Legislative Committee reviewed and provided feedback on the proposals introduced into the January 2025 NCAA Division I Council-governance legislative cycle. The committee noted the development of question-and-answer documents related to several proposals will assist with membership understanding of the potential rule change implications under consideration.
2. **Update on Division I Policy and Legislative Priorities.** The Legislative Committee received an update on the interim policy and legislative priorities approved by the NCAA Division I Board of Directors, which will limit the focus of committees in the governance structure to issues and initiatives that fall within the specified categories. The committee noted that the priorities align with the recommendation and feedback it provided to the Division I Council during its October meeting. During its January meeting, the Legislative Committee will review possible agenda items for January through July and determine which items should be presented to the NCAA Division I Council Coordination Committee for approval.
3. **Approval of the October 31 Legislative Committee Report.** The Legislative Committee approved the report of its October 31 meeting.
