**INFORMATIONAL ITEMS.**

1. **Review of the NCAA Division I Council-Governance Proposals in the October 2023 Council-Governance Legislative Cycle.** The NCAA Division I Legislative Committee reviewed the Division I Council-governance legislative proposals in the October 2023 Council-governance legislative cycle. The Legislative Committee developed initial comments and feedback for consideration by the applicable standing committees and the Division I Council. In addition, the Legislative Committee reviewed recommendations for committees and other entities to review and provide feedback on the proposals in the October 2023 legislative cycle and provided guidance regarding other entities from which feedback should be sought.
2. **NCAA Division I Interpretations Committee Report.** The Legislative Committee received two reports from the Interpretations Committee and approved two official interpretations (References: Update to 08/20/1987, Item No. 1d and 06/08/2023, Item No. 1), as recommended. Further, the Legislative Committee referred the 06/08/2023 (Item No. 1) official interpretation to the NCAA Division I Legislative Committee Modernization of the Rules Subcommittee to review and consider options to deregulate restrictions on providing expenses to student-athletes in conjunction with permissible skill instruction and conditioning activities outside the playing season.
3. **Review Slate of Nominees for Division I Legislative Committee.** The Legislative Committee reviewed the slate of nominees for a vacancy on the committee and provided its recommendations for the NCAA Division I Council Coordination Committee to consider in making an appointment.
4. **Approval of Legislative Committee June Report.** The Legislative Committee approved the report of its June 26-27 meeting.
