**INFORMATIONAL ITEMS.**

1. **Review of Proposals in the October 2024 Legislative Cycle.** The NCAA Division I Legislative Committee reviewed and provided initial feedback on the proposal introduced into the October 2024 NCAA Division I Council-governance legislative cycle.
2. **Update on Potential Recommendation to Discontinue the National Letter of Intent Program.** The Legislative Committee received a status update on the development of a legislative recommendation to incorporate the benefits of the National Letter of Intent (NLI) program into NCAA legislation in a way that would allow for the NLI program to be discontinued as early as prior to this fall's signing periods. The Legislative Committee reviewed the draft concept and provided feedback to assist with the development of the concept. The Legislative Committee will discuss the updated legislative concept during its August 21 videoconference with the potential to recommend that the Division I Council take action during its October 8-9 meeting. The recommendation would be dependent on action by the Conference Commissioners Association to discontinue the NLI program.
3. **Approval of the June 24-25 Legislative Committee Report.** The Legislative Committee approved the report of its June 24-25 meeting.
