**INFORMATIONAL ITEMS.**

1. **Notification of Transfer Window Activity and Transfer Waivers.** The NCAA Division I Legislative Committee received an update on transfer activity during the notification of transfer windows for fall and winter sports for the 2022-23 academic year. The committee received an update regarding the recently updated waiver guidelines being used to evaluate waiver requests for undergraduate four-year transfer student-athletes who do not qualify for a transfer exception.
2. **Application of NCAA Division I Proposal No. 2022-20.** The Legislative Committee received an update on the continued monitoring of application issues associated with the recent changes to legislation that impacts undergraduate four-year transfer student-athletes. The committee requested the NCAA Division I Interpretations Committee review Question No. 12 of the May 17, 2023, education column to determine whether an institution may provide undergraduate four-year transfer student-athletes with multiyear aid agreements that stipulate that a lesser amount of financial aid will be provided in one or more academic years, including the final year of the award.
3. **NCAA Division I Legislative Committee Modernization of the Rules Subcommittee Report.** The Legislative Committee received an update from the Modernization of the Rules Subcommittee on its review of the decentralization items identified in the NCAA Division I Transformation Committee's final report that were referred to the Legislative Committee by the NCAA Division I Council Coordination Committee.
4. **NCAA Media Rights Update.** The Legislative Committee received a media rights update.
5. **Approval of Legislative Committee May Report.** The Legislative Committee approved the report of its May 4 videoconference.
