



**SUPPLEMENTAL REPORT FOR THE
NCAA DIVISION I LEGISLATIVE COMMITTEE
JUNE 24-25, 2024, IN-PERSON MEETING**

INFORMATIONAL ITEMS.

1. **Review of the NCAA Division I Council-Governance Proposals in the June 2024 Council-Governance Legislative Cycle.** The NCAA Division I Legislative Committee reviewed the Division I Council-governance legislative proposals in the June 2024 council-governance legislative cycle. The Legislative Committee provided comments and feedback for consideration by the Division I Council during its legislative agenda.
2. **Update on and Discussion of Division I Governance Issues.** The Legislative Committee received an update on national Division I and Association-wide issues, including the proposed settlement of legal cases.
3. **Review of Additional Transfer-Related Topics.** The Legislative Committee received an update on other transfer related topics, including the legislative recommendations from the sport oversight committees to change the duration of the notification of transfer windows for undergraduate four-year college transfer student-athletes, as well as the changes made to the Division I progress-toward-degree waivers directive.
4. **Update and Discussion on Sports Wagering Legislation Review.** The Legislative Committee received an update on potential changes to sports wagering legislation and provided input on the concepts under consideration, including whether student-athletes and institutional staff should be permitted to wager on professional sports.
5. **2024-25 Division I Council-Governance Pilot Legislative Processes and Recruiting Calendar Pilot.** The Legislative Committee reviewed updated membership resources for the 2024-25 Division I Council-governance pilot legislative processes. The committee noted it will continue to monitor the pilot processes and accompanying resources to determine what additional needs might exist.
6. **NCAA Division I Interpretations Committee Reports.** The Legislative Committee received reports from the Interpretations Committee's May 22 and June 5 videoconferences.
7. **Approval of Legislative Committee May 16 Report.** The Legislative Committee approved the report of its May videoconference.
