**INFORMATIONAL ITEMS.**

1. **Division I Periodic Compliance Review Membership Requirement.** The NCAA Division I Legislative Committee continued to discuss the core areas that should be assessed as a part of the new periodic compliance review membership requirement effective August 1, 2025. The Legislative Committee noted that while the compliance needs differ across Division I campuses, all benefit from processes that promote a culture of institutional control, monitoring and education. The committee directed the staff to develop a framework for the aspects of compliance operations that should be assessed as a means to ensure institutional efforts are focused on serving the needs of student-athletes.
2. **June 2025 NCAA Division I Council-Governance Legislative Cycle.** The Legislative Committee received an update on proposals anticipated for introduction into the June 2025 legislative cycle and will review and provide input on such proposals during its April videoconference.
3. **Update from the NCAA Division I Preenrollment Amateurism Certification Committee.** The Legislative Committee received a report from the Division I Preenrollment Amateurism Certification Committee and approved the recommended updates to the 2025-26 Amateurism Fact-Finding Policies and Procedures and the Amateurism Certification 2025-26 Policies and Procedures.
4. **NCAA Division I Committee for Legislative Relief Report.** The Legislative Committee received the Committee for Legislative Relief's report from its February 20, 2025, videoconference.
5. **Update on Comprehensive Review of Student-Athlete Eligibility Legislation.** The Legislative Committee received an update on the ongoing review of student-athlete eligibility-impacting rules.
6. **Update on Review of NCAA Sports Wagering Legislation.** The Legislative Committee received an update on the division's approach to review of Division I sports wagering legislation.
