



**INFORMATIONAL ITEMS OF THE
NCAA DIVISION I LEGISLATIVE COMMITTEE
OCTOBER 3-4, 2022, MEETING**

INFORMATIONAL ITEMS.

1. **Initial Review of Proposals in the 2022-23 NCAA Division I Council-Governance Legislative Cycle.** The NCAA Division I Legislative Committee reviewed proposals that have been introduced into the 2022-23 Council-governance legislative cycle and provided initial feedback regarding issues of interpretation and application.
2. **NCAA Division I Student-Athlete Advisory Committee Athletics Eligibility Concept.** The Legislative Committee discussed an athletics eligibility concept supported by the Division I Student-Athlete Advisory Committee which would permit student-athletes to participate in intercollegiate athletics competition for five seasons during five-year periods of eligibility. The Legislative Committee supports student-athletes goal of standardizing athletics eligibility across all sports but expressed reservations regarding the concept supported but the Student-Athlete Advisory Committee. The Legislative Committee noted the importance of aligning athletics eligibility with academics in the higher education model and requested additional research be undertaken to review the impact on student-athlete academic pursuits and outcomes if five years of competition is permitted.
3. **NCAA Division I Transformation Committee Update.** The Legislative Committee received an update on the work of the Division I Transformation Committee. The Legislative Committee discussed the work of Transformation Committee in the areas of membership expectations, student-athlete experience and voice, championships and Division I decision-making.
4. **NCAA Division I Committee for Legislative Relief Report.** The Legislative Committee received the Committee for Legislative Relief report from its August 16, 2022, videoconference.
5. **Approval of Legislative Committee September Report.** The Legislative Committee approved the report of its September 8 videoconference.
