NCAA DIVISION I LEGISLATIVE COMMITTEE
OCTOBER 2-3, 2023, IN-PERSON MEETING**

INFORMATIONAL ITEMS.

- 1. Update on Four-Year College Undergraduate Transfer Rates and Waiver Requests.** The NCAA Division I Legislative Committee received an update on four-year undergraduate transfer rates and legislative relief waivers for the 2023-24 academic year.
- 2. Review of Legislative Pilot Processes.** The Legislative Committee engaged in an initial discussion regarding the 2023-24 legislative cycle pilot processes. The committee noted that the pilot processes were designed to accommodate the implementation of sport management committees in a revised governance structure. If sport management committees are not established as was recommended by the NCAA Division I Transformation Committee, it may be necessary to adjust the processes to provide stakeholder (e.g., conferences, sport communities) access to introduce concepts into the legislative process.
- 3. Name, Image and Likeness Update.** The Legislative Committee received an update from the NCAA Division I Council Working Group on Name, Image and Likeness (NIL) on the student-athlete protections proposals that will be recommended to the council during its October 3-4, 2023, meeting for introduction into the January 2024 legislative cycle.
- 4. NCAA Division I Interpretations Committee Report.** The Legislative Committee received the Interpretations Committee report from its August 9, 2023, videoconference.
- 5. NCAA Division I Committee for Legislative Relief Report.** The Legislative Committee received the Committee for Legislative Relief report from its September 28, 2023, videoconference.
- 6. NCAA Division I Committee on Student-Athlete Reinstatement report.** The Legislative Committee received an informational report from the Committee on Student-Athlete Reinstatement.
- 7. Review Slate of Nominees for Division I Legislative Committee.** The Legislative Committee reviewed the slate of nominees for one vacancy on the committee and provided its recommendations for the NCAA Division I Council Coordination Committee to consider in making an appointment.
- 8. Approval of Legislative Committee August 24 Report.** The Legislative Committee approved the report of its August 24 videoconference.
