**INFORMATIONAL ITEMS.**

- 1. Review of the Division I Council-Governance Proposals in the October 2024 Council-Governance Legislative Cycle.** The NCAA Division I Legislative Committee reviewed the Division I Council-governance legislative proposals in the October 2024 council-governance legislative cycle. The Legislative Committee provided comments and feedback for consideration by the Division I Council during its legislative agenda.
- 2. Update on Comprehensive Student-Athlete Eligibility Review.** The Legislative Committee received an update on the Division I Council's ongoing review of student-athlete eligibility-impacting rules. The committee continued to support the concepts under development during the council's initial phase of review and stands ready to assist the council with operational considerations, as needed.
- 3. Update on Requirements for NCAA Transfer Portal Access.** The Legislative Committee continued to discuss the potential implications of access to the Transfer Portal within the established transfer windows. The committee specifically noted the potential timing of operationalizing a new roster limit model and the continued need to assess alignment and access to the Transfer Portal for student-athletes potentially impacted by those changes. The committee will continue to discuss this issue and will seek feedback from the sport oversight committees.
- 4. Approval of Legislative Committee September Report.** The Legislative Committee approved the report of its September 12 meeting.
