DIVISION I MEN'S BASKETBALL OVERSIGHT COMMITTEE
AUGUST 26, 2020, VIDEOCONFERENCE**

INFORMATIONAL ITEMS.

- 1. Review NCAA Division I Name, Image and Likeness Legislative Solutions Group concepts survey.** The NCAA Division I Men's Basketball Oversight Committee received an update on a name, image and likeness concepts survey and sent its recommendations to the Division I Name, Image and Likeness Legislative Solutions Group via the online survey tool.
- 2. Discussion regarding the 2020-21 Division I men's basketball playing season.** The committee discussed and developed options for the 2020-21 men's basketball playing and practice season. The committee narrowed its positions on the first permissible contest date and the first permissible date of preseason practice. The committee agreed to continue its comprehensive review with the NCAA Division I Women's Basketball Oversight Committee prior to forwarding its final recommendations to the NCAA Division I Council for consideration at its September 16 meeting.
- 3. Review of October men's basketball recruiting calendar.** The committee discussed the October and November 2020 recruiting calendar. Based on the continuing impact of the COVID-19 pandemic, the committee recommended the current temporary recruiting dead period be extended through the end of November. It noted the focus on providing prospective student-athletes and their families additional certainty that the dead period will continue to be in effect through the conclusion of the early signing period November 11-18, 2020.
- 4. Approval of reports.** The committee approved its August 13 report and the August 21 report of the NCAA Division I Men's Basketball Oversight Committee Administrative Subcommittee. Further, the committee approved the August 11 report of the NCAA Division I Men's Basketball Oversight Committee Transfer Working Group.
