



**REPORT OF THE NCAA
DIVISION I MEN'S BASKETBALL OVERSIGHT COMMITTEE
AUGUST 23, 2024, VIDEOCONFERENCE**

ACTION ITEMS.

1. Legislative items.

- **Amendment to NCAA Division I Proposal No. 2024-45 – Recruiting – Complimentary Admissions – Postseason Conference Tournament.**
 - (1) Recommendation. The NCAA Division I Men's Basketball Oversight Committee requests the NCAA Division I Council amend Proposal No. 2024-45 to add men's basketball.
 - (2) Effective date. Immediate.
 - (3) Rationale. This proposal promotes the growth of conference championship events through additional attendance and the opportunity for enhanced community for engagement. For example, conference offices would be permitted to provide complimentary admissions to community organizations or school districts. Allowing conferences to provide complimentary admissions unrelated to recruitment will not impact competitive equity between member schools. Selection of specific recipients (as individuals, teams or athletics programs) would not be permissible. Any complimentary admission provided by a conference must be unrelated to athletics recruitment and not involve athletics staff at member schools (or boosters) in any way. No recruiting activities in conjunction with the conference championship would be permitted.
 - (4) Estimated budget impact. Dependent on conference decision-making.
 - (5) Student-athlete impact. None.

2. Nonlegislative items.

INFORMATIONAL ITEMS.

1. Review of select Division I proposals in the 2024 October legislative cycle.

- a. **Proposal No. 2024-46 – Recruiting – Notification of Transfer Windows – Reduce From 45 Days to 30 Days – Basketball and Football.** The Men's Basketball Oversight Committee reviewed Proposal No. 2024-46 and continued to provide support for the proposed changes as it pertains to men's basketball. The committee noted the NCAA Division I Men's Basketball Student-Athlete Engagement Group (SAEG) expressed differing opinions on Proposal No. 2024-46 including that shortening the window allows for current student-athletes to have an earlier idea of what their team will look like prior to the start of the summer access, while other student-athletes noted that the current 45-day window allows student-athletes to receive the time they need to make

a thoughtful decision on where to transfer. The Council is expected to vote on this proposal during its October meeting.

- b. Proposal No. 2024-50 – Playing and Practice Seasons – Basketball – First Permissible Contest Date and 22-Week Playing Season.** The Men's Basketball Oversight Committee reviewed Proposal No. 2024-50 but did not take action. The committee agreed to continue discussions and give consideration to amending the proposal to a Monday start date prior to adoption. The committee is expected to take action, including possible amendment, during its October in-person meeting.
- 2. Men's basketball signing date model discussion.** The committee discussed the proposed new signing date model. The committee will provide feedback after the joint NCAA Division I Men's and Women's Basketball Oversight Committees' videoconference in September.
- 3. NCAA College Basketball Academy review.** The committee discussed the 2024 NCAA College Basketball Academy that occurred in Rock Hill, South Carolina. The committee also received an update on the survey results from the 2024 CBA. Specifically, the committee noted players, chaperones and Division I coaches were surveyed after the conclusion of the Academy and the results demonstrated a high satisfaction rating among participants for on court activities and life skills programming.
- 4. Review of proposed travel day blanket waiver.** The NCAA Division I Committee on Legislative Relief (CLR) requested feedback from all standing committees on a potential blanket waiver that would allow a travel day to be used as a student-athlete's day off, provided certain criteria were met. The Men's Basketball Student-Athlete Engagement Group and the Men's Basketball Oversight Committee requested CLR add men's basketball to the blanket waiver for the 2024-25 playing season.
- 5. NCAA Division I Men's Basketball Student-Athlete Engagement Group update.** The committee received an update from SAEG's August 20 videoconference.
- 6. NCAA Division I Men's Basketball Oversight Committee Outside Competition Working Group update.** The committee received an update on outside competition legislation.
- 7. Men's basketball multiple-team event discussion.** The committee received an update on recent multiple-team event educational materials that were distributed to the membership and event operators in August.
- 8. NCAA Division I Men's Basketball Committee update.** The committee received an update from the July 8-10 Men's Basketball Committee meeting.
- 9. Identification of discussion topics for the Men's and Women's Basketball Oversight Committees' September 4 joint videoconference agenda.** The committee was asked to identify any topics to be discussed during the upcoming joint Men's and Women's Basketball Oversight Committee videoconference on September 4.
