**INFORMATIONAL ITEMS.**

1. **Multiple-team event discussion.** The NCAA Division I Men's Basketball Oversight Committee continued its comprehensive review of the multiple-team event (MTE) legislation and corresponding maximum contest limitations. The committee discussed three initial MTE concepts and agreed to continue to explore two of these concepts during its February 28, 2025, meeting. The committee anticipates sponsoring a legislative proposal into the June 2025 legislative cycle that would alter the existing maximum contest limitations as early as the 2025-26 men's basketball season. Finally, the committee also took action to extend the current MTE blanket waiver to the 2025-26 season.
2. **Review potential addition to Men's Basketball Oversight Committee interim policy and legislative priorities.** The committee reviewed its policy and legislative initiatives that were approved during its January 14 meeting. During its January 31 meeting, the committee took action to add additional initiatives to its policy and legislative priorities request. The updated committee policy and legislative priorities document will be submitted to the NCAA Division I Council Coordination Committee for its review and approval. Finally, the committee agreed to add the topic of youth player development pipeline to its future discussion items as early as fall 2025.
3. **Identification of discussion topics for the NCAA Division I Men's and Women's Basketball Oversight Committees' joint meeting agenda.** The committee was asked to identify any topics to be discussed during an upcoming joint meeting on April 24, 2025.
4. **Men's Basketball Oversight Committee January 14 addendum report.** The committee reviewed and approved its January 14 addendum report.
