



**REPORT OF THE NCAA
DIVISION I MEN'S BASKETBALL OVERSIGHT COMMITTEE
JANUARY 6, 2026, VIDEOCONFERENCE**

ACTION ITEMS.

- **None.**

INFORMATIONAL ITEMS.

1. Legislative Items.

a. Unofficial (Nonpaid) Visit – First Opportunity to Visit - Men's Basketball.

- (1) **Action.** The NCAA Division I Men's Basketball Oversight Committee introduced legislation to permit unofficial visits at any time, subject to recruiting calendar restrictions per Division I Bylaw 13.17.2.
- (2) **Effective Date.** Immediate.
- (3) **Rationale.** This proposal increases exposure of collegiate athletics to encourage and promote collegiate attendance. Additionally, unofficial visit opportunities for men's basketball prospective student-athletes would align with women's basketball and football prospective student-athletes.
- (4) **Estimated budget impact.** Potential costs associated with minimal expenses during unofficial visits, which vary by institution based on recruiting practices.
- (5) **Student-athlete impact.** The proposal supports informed decision-making during the recruiting process.

b. Recruiting – Evaluations – Men's Basketball – May and July Evaluation Periods – Regularly Scheduled International Scholastic Team or Nonscholastic Team Practice and Competition.

- (1) **Action.** The oversight committee introduced legislation to permit evaluations of international prospective student-athletes participating on international scholastic or nonscholastic teams during regularly scheduled practice and competition during the May and July evaluation periods.
- (2) **Effective Date.** Immediate.
- (3) **Rationale.** This proposal provides increased flexibility for international recruiting and increases exposure of collegiate athletics to international prospective student-athletes.

- (4) Estimated budget impact. Varies by institution based on time recruiting off campus.
- (5) Student-athlete impact. The proposal supports informed decision-making during the recruiting process.

2. **NCAA Division I legislative discussion.** The NCAA Division I Men's Basketball Oversight Committee reviewed and continued discussion on several potential concepts for future legislative changes. Specifically, the oversight committee discussed: (a) once-in-four-year foreign tour timing; (b) number of preseason practice scrimmages and exhibition games; (c) summer access hours and types of activities; and (d) number of coaches and off-campus recruiters. The Division I Men's and Women's Basketball Oversight committees will continue to discuss these concepts at their next joint meeting.
3. **Men's basketball research update.** The oversight committee received an informational update from the NCAA research staff on recent men's basketball transfer data, transfer trends and graduation rate data.
4. **Men's basketball seasonal update.** The oversight committee received an informational update on the 2025-26 men's basketball regular season. Specifically, the oversight committee received television viewership data specific to Thanksgiving contests and other social media metrics.
5. **NCAA playing rules and statistics update.** The oversight committee received an update on playing rules and statistics during the 2025-26 men's basketball regular season. Specifically, the oversight committee was informed game length (two hours and one minute) through December 31, 2025, is the shortest it has been since the 2022-23 season (one hour and fifty-eight minutes).
6. **NCAA Division I Men's Basketball Committee and Oversight Committee reception at the 2026 Men's Final Four.** The oversight committee received an update that a reception is being planned to take place in conjunction with the 2026 Men's Final Four in Indianapolis in honor of the 10-year anniversary of the formation of the Men's Basketball Oversight Committee.
7. **National Association of Basketball Coaches update.** Due to time constraints, the oversight committee will review this agenda item at a future meeting.
8. **Identification of discussion topics for the upcoming NCAA Division I Men's and Women's Basketball Oversight Committees' joint meeting.** The oversight committee identified topics to be discussed during its next joint meeting.

9. **NCAA Division I Men's Basketball Oversight November 21 and December 1, 2025, meeting reports.** The oversight committee approved the November 21 and December 1, 2025, Division I Men's Basketball Oversight Committee meeting reports.
10. **Other business.** The oversight committee received an update on student-athlete eligibility issues from the NCAA office of legal affairs and NCAA Eligibility Center.
