



**REPORT OF THE NCAA
DIVISION I MEN'S BASKETBALL OVERSIGHT COMMITTEE
JUNE 14, 2021, VIDEOCONFERENCE**

ACTION ITEMS.

INFORMATIONAL ITEMS.

1. **Review of nominees for the NCAA Division I Men's Basketball Oversight Committee member vacancies.** The committee reviewed the slate of nominees for two non-Council vacancies on the Men's Basketball Oversight Committee and provided feedback to be considered by the NCAA Division I Council Coordination Committee.
2. **Review of nominees for head coach representative to the NCAA Division I Men's Basketball Competition Committee member vacancy.** The committee reviewed the nominees for one head coach vacancy on the Men's Basketball Competition Committee and provided feedback to be considered by the Council Coordination Committee.
3. **Discuss NCAA Division I Women's Basketball Oversight Committee Legislation Subcommittee multiple-team event recommendation to the NCAA Division I Council.** The committee reviewed a legislative proposal from the Women's Basketball Oversight Committee that would amend the maximum contest date limitations in women's basketball. The proposal is similar to the current legislation in men's basketball that permits an institution to participate in:
 - a. Twenty-eight contests (games and scrimmages) and one qualifying regular-season multiple-team event that does not exceed three contests;
 - b. Twenty-nine contests (games and scrimmages) and one qualifying regular-season multiple-team event that does not exceed two contests; or
 - c. Twenty-nine contests (games and scrimmages) during a playing season in which the institution does not participate in a qualifying regular-season multiple-team event.

However, the women's basketball proposal would also permit institutions to participate in a championship game as part of option (a) that would be exempted from the contest limitations. In these circumstances, an institution could participate in a four-game multiple-team event.

Although the committee acknowledged the benefit of having consistent maximum contest limitations in men's and women's basketball, based on the extensive examination of the multiple-team event legislation from October 2018 until April 2020, it reaffirmed its support of the current legislation which was just adopted in April 2020. Specifically, the

committee agreed that a maximum of three-game MTEs should be maintained regardless of any contest exemptions due to issues associated with fourth "tack-on" games once prevalent in men's basketball and the competitive advantage gained with participation in additional contests beyond the current legislated maximums.

4. **NCAA Minority Opportunities and Interests Committee update regarding senior minority administrator designation.** The committee received an update from the MOIC's recent review of the senior minority administrator concept. The oversight committee directed the staff to develop a legislative proposal and associated educational materials for review during its July meeting. Once the proposal is final, the oversight committee plans to seek support from other Council standing committees prior to requesting the Council to introduce it into the 2021-22 legislative cycle.
5. **NBA pre-draft process update.** The committee received an update on the NBA pre-draft process including current data on early entry candidates and a timeline of upcoming NBA pre-draft process events.
6. **Name, image and likeness update.** The committee received an update on the name, image and likeness proposals that the Council will review during its June 22-23 meeting.
7. **National Association of Basketball Coaches update.** The committee received an update on how the NABC plans to increase its engagement in the NCAA Division I governance process.
8. **Overtime Elite League.** The committee received an update on the Overtime Elite high school basketball league.
9. **Update on men's basketball secretary rules editor position.** The committee received an update on the upcoming secretary rules editor vacancy and was encouraged to actively participate in identifying qualified candidates for the application process.
10. **NCAA Division I Men's Basketball Oversight Committee May 27 videoconference report.** The committee reviewed and approved its May 27 videoconference report.
