

REPORT OF THE NCAA DIVISION I MEN'S BASKETBALL OVERSIGHT COMMITTEE MARCH 25, 2025, VIDEOCONFERENCE

ACTION ITEMS.

INFORMATIONAL ITEMS.

- 1. Men's Basketball Oversight Committee chair and vice chair update on multiple-team event discussion with the NCAA Division I Women's Basketball Oversight Committee chair and vice chair. In preparation for the March 25 joint meeting, the committee continued its comprehensive review of the multiple-team event (MTE) legislation and corresponding maximum contest limitations. The committee also received an update on a recent joint discussion with the MBOC and WBOC Chairs and Vice Chairs on the oversight committees' multiple-team event reviews. A summary of the discussion was shared with WBOC during the March 25 joint meeting.
- 2. Review of NCAA Division I Women's Basketball Oversight Committee Exhibition Contest Proposal. The committee reviewed a WBOC sponsored proposal that would permit an NCAA Division I women's basketball team to play an exhibition game or practice scrimmage against any collegiate institution, including two-year colleges. The committee chose not to request the NCAA Division I Council add men's basketball to the women's basketball proposal noting the committee supports the current legislation that only permits a Division I men's basketball team to play a practice scrimmage or exhibition game against teams from any four-year collegiate institution.
- 3. 2025-26 Division I Men's Basketball recruiting calendar. The committee reviewed the proposed 2025-26 Division I men's basketball recruiting calendar and requested the NABC provide its feedback on the recommended June 2026 scholastic events dates of June 12-14 and June 26-28, 2026, due to dead periods June 19 and 21, 2026. The committee expects to approve the 2025-26 recruiting calendar during its May 6, 2025, meeting.
- 4. Review NCAA Division I Men's Basketball Oversight Committee nominations. The committee reviewed and shared their recommendations for the Division I Men's Basketball Oversight Committee vacancy that will be provided to the Council Coordination Committee for approval.
- 5. National Association of Basketball Coaches update. The National Association of Basketball Coaches provided an update regarding the upcoming NABC Convention, April 3-6, which will occur in San Antonio, Texas, during the NCAA Division I Men's Basketball Final Four weekend.

- **6. Legislative priorities update.** The committee received an informational update on the legislative priorities that were approved by the NCAA Division I Council Coordination Committee.
- 7. Identification of discussion topics for upcoming NCAA Division I Men's and Women's Basketball Oversight Committee's joint meeting. The committee was asked to identify any topics to be discussed during the next joint meeting on April 24, 2025.
- **8. Other business.** The committee received an update on a legislative relief waiver seeking to waive the once-in-four-year foreign tour legislation.
