



**REPORT OF THE NCAA DIVISION I
MEN'S AND WOMEN'S BASKETBALL OVERSIGHT COMMITTEES
NOVEMBER 19, 2020, JOINT VIDEOCONFERENCE**

INFORMATIONAL ITEMS.

1. **Update from the November 18, 2020, NCAA Division I Council videoconference.** The NCAA Division I Men's and Women's Oversight Committees were provided an update on the extension of the COVID-19 temporary dead period through April 15, 2021, for all sports and the request for financial aid exemptions for future years, which was tabled and will be revisited at the Council's December 16 meeting.
2. **NCAA Medical Advisory Panel update on basketball.** The oversight committees received an update regarding testing frequency and issues related to quarantine protocol.
3. **Request for a blanket waiver of the winter break legislation.** The oversight committees reviewed and provided feedback on a potential blanket legislative relief waiver related to the three-day winter break period legislation in basketball for the 2020-21 season. The committees supported a blanket waiver to permit required athletically related activities during the three-day winter break period in basketball.
4. **Minimum number of student-athletes required to conduct a basketball contest.** The committees were provided an update regarding the minimum number of student-athletes required to start a basketball contest for the 2020-21 season. Member conferences will be responsible for determining the minimum for conference contests and member institutions will be responsible to determine the minimum for nonconference contests.
5. **NCAA Men's and Women's Basketball Playing Rules COVID-19 update.** The oversight committees received updates from the Men's and Women's Basketball Rules Committees, including conferences establishing their own policies for games completion, especially when there are circumstances that might necessitate a contest finishing with less than two officials.
