

REPORT OF THE NCAA DIVISION I MEN'S AND WOMEN'S BASKETBALL OVERSIGHT COMMITTEES OCTOBER 3, 2023, JOINT MEETING

INFORMATIONAL ITEMS.

1. Update on the NCAA College Basketball Summer Basketball Initiative. The NCAA Division I Men's and Women's Basketball Oversight Committees received an update on the men's and women's College Basketball Summer Basketball Initiative. The update included informing the joint oversight committees of the sunsetting of the NCAA Division I Women's Basketball Summer Basketball Initiative Working Group and the referral of summer initiative concepts to the NCAA Division I Women's Basketball Oversight Committee (WBOC). The update also included recent discussion by WBOC to introduce deregulation of publicity of out-of-season and summer access skill instruction and continued exploration of foreign tours to occur once every two years rather than once every four years.

The NCAA Division I Men's Basketball College Basketball Summer Initiative Working Group continues to meet via monthly videoconferences to identify and discuss alternative summer basketball participation opportunities as well as additional men's basketball areas of review. Currently, the working group has begun discussing similar recommendations for publicity of skill-instruction and foreign tours as the WBOC. Further, the working group has referred for further review a potential modification to preseason exhibitions and practice scrimmages (e.g., exhibition against another Division I institution, open practice scrimmages) and potentially considering lengthening the window when these preseason contests could occur.

- 2. NCAA Division I men's and women's basketball championship bracket access update. The oversight committees received an update on current discussions related to the NCAA Division I men's and women's basketball championship bracket access. The oversight committees also received updates on upcoming postseason participation opportunities and efforts by the championship committees to create equitable opportunities for both Division I men's and women's basketball student-athletes.
- 3. NCAA championship broadcast agreement update. The oversight committees received an update on the current broadcast rights agreement process for select NCAA championships. Further updates on the agreement discussions will be shared in the next few months.
- 4. Impact of Division I conference realignment on college basketball. The oversight committees received an update on the impact that recent conference realignment may have on college basketball. The staff will monitor and identify legislation and policies that may need to be examined in light of the conference changes. For example, an examination of the qualifying regular season multiple-team events criteria limiting annual participation to

one school per conference in an event may be warranted now that conferences have increased their membership. Initial discussions are expected to begin at the January 2024 joint meeting.

- 5. Identification of discussion topics for the January 2024 joint NCAA Division I Men's and Women's Basketball Oversight Committees meeting. The oversight committees were asked to identify topics to be discussed during the upcoming joint Men's and Women's Oversight Committees meeting in January 2024.
- 6. NCAA Division I Men's and Women's Basketball Oversight Committees' August 29 videoconference report. The committee reviewed and approved the August 29 videoconference report.
