



**REPORT OF THE NCAA
DIVISION I MEN'S BASKETBALL OVERSIGHT COMMITTEE
OCTOBER 6-7, 2025, MEETING**

KEY ITEMS.

1. **Legislative action pending NCAA Division I Cabinet review.** The NCAA Division I Men's Basketball Oversight Committee took the following key legislative action. Note, the proposal is effective immediately pending review by the NCAA Division I Cabinet during its October 7-8, 2025, meeting.
 - **NCAA Division I Proposal No. 2025-19 -- Recruiting – Tryouts and Sports Camps and Clinics – Definition of Prospective Student-Athlete – Men's Basketball.** The oversight committee adopted Proposal No. 2025-19. The proposal changes the definition of a prospective student-athlete in men's basketball, for tryouts and sports camps and clinics, to an individual who has begun classes for the ninth grade.
2. **Review of draft policies and procedures.** The oversight committee recommended the Division I Cabinet consider the addition of a fourth legislative cycle to the Division I 2025-26 legislative year that would conclude with the cabinet's April 14-15, 2026, meeting.

INFORMATIONAL ITEMS.

1. **2025-26 Division I Men's Basketball recruiting calendar.** As recommended by the National Association of Basketball Coaches, the oversight committee approved modifications to the Division I men's basketball recruiting calendar as noted below. The changes are effective immediately; however, contracts signed prior to October 7, 2025, may be honored. The changes are as follows:
 - a. Create a seven-day quiet period beginning the Monday immediately following the second evaluation period in July. Days in July after the seven-day quiet period shall be a dead period;
 - b. Extend the August dead period to August 1 through the third Wednesday in August. Days in August after the third Wednesday in August shall be a quiet period.
2. **Committee orientation and review of draft policies and procedures.** The oversight committee received an orientation from the staff and was provided an opportunity to provide feedback on draft policies and procedures.
3. **NCAA Division I Men's Basketball Oversight Committee vacancies.** The oversight committee appointed new members to the committee. Notification to the appointees will follow the established process and rosters will be updated in accordance with the start date for service.

4. **NCAA Division I Men's Basketball Oversight Playing Rules Subcommittee vacancies.** The oversight committee appointed new members to the Men's Oversight Basketball Committee Playing Rules Subcommittee. Notification to the appointees will follow the established process and rosters will be updated in accordance with the start date for service.
5. **Review of future topics list.** The oversight committee considered and prioritized topics for future discussion.
6. **NCAA Division I Men's Basketball Tournament considerations.** The oversight committee discussed future tournament considerations for the future NCAA Division I Men's Basketball Tournament.
7. **Review of NCAA Division I Men's Basketball Committee reports and 2026 Division I Men's Basketball Tournament Team Replacement Policy.** The committee reviewed the spring and summer NCAA Division I Men's Basketball Committee reports and approved the 2026 Division I Men's Basketball Tournament Team Replacement Policy.
8. **NCAA Division I Men's Basketball Head Coaches communication.** The committee received an update on the NCAA national office's comprehensive communication strategy to strengthen the relationship between the NCAA, the NABC leadership groups and Division I head men's basketball coaches.
9. **NCAA Division I Men's Basketball Student-Athlete Engagement Group update.** The oversight committee received an update from the Division I Men's Basketball Student-Athlete Engagement Group (SAEG). The Men's Basketball SAEG will conduct its first virtual meeting of the 2025-26 academic year on October 26.
10. **NABC update.** The oversight committee received an update from the NABC.
11. **NCAA Men's Basketball Oversight Playing Rules Subcommittee update.** The oversight committee received an update on the rules changes and points of emphasis from the men's basketball secretary-rules editor ahead of the 2025-26 men's basketball season.
12. **NCAA Division I Men's Basketball Officiating updates.** The oversight committee received an update from the national coordinator of men's basketball officials ahead of the 2025-26 season. The national coordinator noted how successful the in-person fall officiating clinics were for the growth and development of the officials especially with several rules changes following the most recent rules change cycle.

13. **Identification of discussion topics for the upcoming NCAA Division I Men's and Women's Basketball Oversight Committees' joint meeting.** The oversight committee identified topics to be discussed during its next joint meeting.
14. **Joint meeting with the NCAA Division I Academics and Eligibility Committee, NCAA Division I Football Championship Subdivision Oversight Committee, NCAA Division I Men's Basketball Oversight Committee and NCAA Division I Women's Basketball Oversight Committee.** The Men's Basketball Oversight Committee received an update from the NCAA Office of Legal Affairs, NCAA Government Relations and the Collegiate Sports Commission.
15. **NCAA Division I Men's Basketball Oversight June 2 videoconference.** The oversight committee approved the June 2 Division I Men's Basketball Oversight Committee videoconference report.
