- **2020-21 NCAA Division I men's and women's basketball season.** The NCAA Division I Men's and Women's Basketball Oversight Committees met jointly to finalize recommendations to the NCAA Division I Council related to the upcoming basketball season.

- **2020-21 NCAA Division I men's and women's basketball season and COVID-19 impact.** The Men's and Women's Basketball Oversight Committees met jointly to address several items related to the upcoming basketball season and took into consideration the evolving impact of the COVID-19 pandemic. The oversight committees continued their work in finalizing recommendations in the following areas:
 - a. First permissible contest date.
 - b. Out-of-season and preseason practice model.
 - c. Scrimmages and exhibitions.
 - d. Multi-team event legislation.
 - e. Three-day winter break.

The oversight committees did refer the review of minimum and maximum number of contests to the respective basketball committees. It is expected that recommendations be made to the oversight committees in time for a recommendation to be forwarded to the Council for its September 16, 2020, meeting.
