

REPORT OF THE NCAA DIVISION I PRESIDENTIAL FORUM JANUARY 23, 2019, MEETING



INFORMATIONAL ITEMS.

- 1. Review of NCAA Division I Academic Misconduct Working Group Final Report. The NCAA Division I Presidential Forum received a final report from the NCAA Division I Academic Misconduct Working Group. The Presidential Forum reviewed and discussed the final report and will continue its discussions over the next several months. The NCAA Division I Presidential Forum Steering Committee will develop concepts and recommendations regarding academic misconduct for discussion by the Presidential Forum in April. During its April meeting, the Presidential Forum will finalize its initial recommendations for membership feedback through the spring and summer conference and governance meetings. It is anticipated the Forum will provide the NCAA Division I Board of Directors with a final report later this year. Key areas of discussion included:
 - a. Whether it is necessary for each campus to have a mechanism for reviewing academic integrity issues involving student-athletes (e.g., campus committee with such responsibility) and/or examples of possible options to help campuses (e.g., best practices).
 - b. Ways to ensure truly egregious academic misconduct is captured as an NCAA violation while balancing the appropriate role of the NCAA so as to not have NCAA "overreach."
 - c. Referral of the interpretations process in infractions matters to the NCAA Division I Council for further vetting with an expectation for a report on the issue later this year. This referral was consistent with the working group's recommendation for additional review by another governance body based on the broad scope of the issue beyond academic misconduct.
 - d. Support for the recommended legislative edits that are noncontroversial in nature and improve clarity of the existing legislation. The Presidential Forum also supports outreach to the regional accrediting agencies for the purpose of communication and clarity of roles in the area of academic misconduct.

Presidential Forum members were asked to communicate with their conference commissioners to consider adding a discussion of academic misconduct to the agenda of spring/summer conference meetings involving presidents and chancellors. Based on discussions at the Presidential Forum's April meeting, a report will be provided to help frame key items for membership feedback. Each conference's feedback will be considered as the recommendations to the Board are finalized. The following graphic provides the anticipated timeline for review:

2. Discussion on Presidential Accountability, Certification of Compliance and Attestation. The Presidential Forum continued a discussion related to the Commission on College Basketball's suggestion for increased accountability for presidents, directors of athletics and coaches. In order to bolster existing accountability measures (e.g., certification of compliance) in August 2018, the Board of Directors adopted legislation to (1) add an attestation requirement; (2) require contracts to include responsibility to cooperate in investigations; and (3) increase culpability for hiring individuals under an enforcement "show cause" order.

As it relates to presidential accountability, the Presidential Forum noted that institutional boards of regents already hold presidents accountable for fulfilling their responsibilities. In addition, previously adopted legislation provides that a president may be mentioned by name in an infractions report. The annual attestation requirement will help ensure presidents understand their responsibilities for institutional control and rules compliance. In order to receive a nonpresidential perspective, the Forum supports the Board's recommendation that it would be valuable to have the independent members of the NCAA Board of Governors review the presidential accountability document and feedback.

As it relates to accountability of directors of athletics, the Presidential Forum recommend that the Council, made up of many directors of athletics, provide perspective to the

Presidential Forum on accountability for directors of athletics for consideration prior to any action. This examination should include desired outcomes of such a review (e.g., best practices, legislative requirements).

As it relates to accountability of coaches, expectations for head coach control of his or her program and related responsibilities have previously been identified and legislated. However, additional work should be done to develop behavioral expectations, consistent with the Board of Directors' strategic areas of emphasis, which notes an interest in examining and creating expectations for the role of coaches and athletics administrators, including improved leadership training.

- 3. Update on Association-Wide Vote to Add Five Independent NCAA Board of Governors. The Presidential Forum received a final update related to the Association-wide vote to add five independent Governors.
- 4. Progress on the "Charting the Course" Inventory. The Presidential Forum received a progress report on the development of an inventory of successful campus programming designed to ensure a well-rounded student-athlete experience. An online database is under development to catalog effective student-athlete well-being programming that is currently occurring throughout the membership, as well as materials and programs developed by the NCAA national office. Presidents or chancellors and athletics administrators will have the opportunity to review information related to the programs and consider implementing them (or elements of them) on their campuses. Among the topics that will be included in the tool are topics related to academic risk, mental wellness, career planning, mentoring, life skills, concussion protocol and sexual violence prevention.
- 5. Report of the October 22-23, 2018, NCAA Division I Presidential Forum Meeting. The Presidential Forum approved the report of its October meeting. (*Unanimous voice vote.*)
