Background: *During its June 25-26, 2024, meeting, the NCAA Division I Council authorized a comprehensive review of the eligibility impacting rules for student-athletes to align them with the changing environment and the needs of today's student-athletes. While the review is underway, the council authorized NCAA staff to apply reasonable discretion when reviewing eligibility cases and interpretation requests, considering mitigating factors and the intent of the legislation. The committee will receive examples of discretion staff used to reach outcomes that would not have been likely had the staff strictly adhered to existing regulatory parameters. Use of such discretion has resulted in more reasonable outcomes in appropriate cases.*

Strategic Items for Discussion

7. Review of Division I legislation related to season-of-competition and hardship waivers received from other organizations (e.g., National Junior College Athletic Association) [Supplement No. 3]

Background: *The committee will review and provide feedback on the application of season-of-competition and hardship waivers that are granted by other organizations when a student-athlete transfers to a Division I institution. Additionally, the committee will review Division I use of season legislation as it relates to other organizations.*

8. Review of recommendation from the NCAA Committee on Women Athletics. [Supplement No. 4]

Background: *The committee will review and discuss a recommendation from the Committee on Women Athletics related to limited flexibility for student-athletes requesting an extension of eligibility waiver and who compete in a sport that becomes part of the emerging sport process and have at least two denied participation opportunities prior to the NCAA sponsoring the sport.*
