INFORMATIONAL ITEMS.

1. **NCAA Student-Athlete COVID-19 Well-Being Survey.** The NCA Division I Student-Athlete Advisory Committee received an update on the NCAA Student-Athlete COVID-19 Well-Being survey from NCAA research staff.
2. **Student-Athlete Advisory Committee Priorities for 2020-21.** The Student-Athlete Advisory Committee developed guiding themes for its strategic priorities for the 2020-21 academic year in the areas of the 21st century collegiate model (with a specific focus on the impact of COVID-19), diversity and inclusion, student-athlete communication, and student-athlete health and well-being. The Student-Athlete Advisory Committee will continue to identify areas of opportunity to create educational resources to enhance the student-athlete experience and collaborate with other Division I committees and governance bodies.
3. **Review of Student-Athlete Advisory Committee Nominations for New Members.** The Student-Athlete Advisory Committee executive team reviewed nominations submitted by conferences and appointed new members.
