



**REPORT OF THE
NCAA DIVISION I STUDENT-ATHLETE ADVISORY COMMITTEE
JANUARY 12 AND 15, 2021, VIDEOCONFERENCE**

INFORMATIONAL ITEMS.

1. **Approval of the NCAA Division I Student-Athlete Advisory Committee October 22, 2020, meeting report.** The Division I Student-Athlete Advisory Committee reviewed and approved the report from its October 22 meeting.
2. **NCAA guest speakers.** The Student-Athlete Advisory Committee welcomed several guest speakers:
 - a. Mark Emmert, NCAA president, provided an update and answered questions regarding key issues impacting the Association.
 - b. Dr. Brian Hainline, NCAA chief medical officer, provided an update on issues related to the ongoing COVID-19 pandemic, including the impact of vaccine rollout on NCAA championships.
 - c. Jack DeGioia, president of Georgetown University and incoming chair of the NCAA Board of Governors, and Donald Remy, NCAA chief operating officer/ chief legal officer, provided updates on the actions of the Board of Governors and issues impacting the Association.
3. **NCAA Division I Student-Athlete Experience Committee structure.** The Student-Athlete Advisory Committee discussed potential improvements to the Student-Athlete Experience Committee's structure. The committee highlighted several potential areas of improvement, including a standardized onboarding/ transition process for new national SAAC members, improved communication with conference and institutional SAACs, using subcommittees to better educate all student-athletes on key issues and rebranding SAAC to better reflect the committee's role within the governance structure. These, along with other areas of improvement, will be discussed further at the next SAAC meeting on March 3.
4. **Leadership and committee vacancies.** The Student-Athlete Advisory Committee reviewed the leadership and committee vacancies within the committee's executive team and the NCAA Division I Council standing committees. Members interested in executive team positions will present to the committee at an upcoming meeting, followed by an online vote.

5. **Council, Council standing committees and Association-wide committee updates.** The Student-Athlete Advisory Committee received updates on recent activities and decisions made by Council, Council's seven standing committees and Association-wide committees. Specifically, the committee reviewed the outcomes of the January 11 Council meeting, including the Council's decision to delay consideration of the name, image and likeness and transfer legislative proposals. These decisions were made in response to concerns from the U.S. Department of Justice Antitrust Division regarding aspects of the legislative proposals.
6. **Division I proposed legislation.** The Student-Athlete Advisory Committee received an overview of legislation adopted during the January 11 Council meeting, as well as the legislative proposals slated for consideration in April.
7. **Student-Athlete Advisory Committee Conference updates.** Each conference Student-Athlete Advisory Committee representative reported on any conference initiatives or updates. These reports demonstrated that many conferences are focusing on diversity and inclusion, student-athlete mental health and virtual/ remote community service initiatives.
