INFORMATIONAL ITEMS.

1. **2020 NCAA Division I Name, Image and Likeness Survey.** The NCAA Division I Student-Athlete Experience Committee provided feedback on the 2020 NCAA Division I Name, Image and Likeness Survey. The staff submitted the feedback via the survey request from the NCAA Division I Name, Image and Likeness Legislative Solutions Group.
2. **2020-21 recruiting calendars – extension of dead period.** The Student-Athlete Experience Committee engaged in a discussion on potential modifications to the temporary COVID-19 recruiting dead period. The committee supported extending the temporary recruiting dead period beyond September and expressed support for discontinuing the month-by-month extension approach to a more extended period of time in the interest of providing clarity and protecting student-athlete health and safety. Additionally, the committee indicated support for maintaining the National Letter of Intent early signing period in November 2020, to maintain normalcy in the recruiting for prospective student-athletes ready to sign the NLI.
