INFORMATIONAL ITEMS.

1. **Legislative request – in-season foreign competition.** The NCAA Division I Student-Athlete Experience Committee considered a request to remove the once-every-four-years limit on in-season foreign competition. The committee elected to not approve a blanket waiver request for the 2023-24 academic year. The committee will discuss the current restrictions on the in-season foreign competition limit during an upcoming meeting.
2. **Transfer issues – undergraduate four-year transfers – review of transfer windows.** The committee reviewed data and discussed transfer windows in sports other than football and basketball, including the duration and timing of notification of transfer windows. The committee will continue its review at its October in-person meeting.
3. **Baseball – institutional official visit and roster limit – review draft survey.** The committee reviewed and provided feedback on a draft survey concerning the institutional official visit limit and varsity squad-size limit in baseball.
