INFORMATIONAL ITEMS.

1. **Update from NCAA Division I Legislative Committee Modernization of Rules Subcommittee – professional opportunities and outside competition.** The NCAA Division I Student-Athlete Experience Committee (SAEC) received an update from the chair of the Modernization of the Rules Subcommittee and provided feedback on legislative concepts related to outside competition and professional opportunities before and after enrollment.
2. **Volleyball – American Volleyball Coaches Association (AVCA) – Showcase.** The SAEC reviewed a request to allow institutions participating in a preseason showcase hosted by the AVCA to begin preseason practice seventeen days before the event. The committee requested feedback from the NCAA Division I Student-Athlete Advisory Committee and the NCAA Division I Competition Oversight Committee and will continue its consideration during its January meeting.
3. **NCAA Division I Proposal No. 2023-45 (recruiting – publicity before recruitment – photographs during an unofficial visit – FBS).** The SAEC discussed whether Proposal No. 2023-45, which will preclude an institution from arranging for photographs during an unofficial visit, should extend to all sports other than basketball and football. The SAEC will continue its discussion during a future meeting.
