

REPORT OF THE NCAA DIVISION I STUDENT-ATHLETE EXPERIENCE COMMITTEE FEBRUARY 15, 2021, VIDEOCONFERENCE

ACTION ITEMS.

• NCAA Division I Amateurism Certification Process. The NCAA Division I Student-Athlete Experience Committee reviewed and approved the 2021-22 Amateurism Certification Process policies and procedures.

INFORMATIONAL ITEMS.

- 1. NCAA Division I Presidential Forum Sustainability Review Short-Term Sustainability Issues. The committee reviewed its timing recommendations for concepts included in the Presidential Forum Sustainability Review.
- 2. 2021 comprehensive recruiting review. The committee received an update from staff regarding the previously conducted early recruiting review, which focused on the timing of the recruitment process. The committee engaged in initial conversations regarding the comprehensive recruiting review chart, which focuses on how institutions recruit prospective student-athletes.
- 3. 2021 spring out-of-season activities. The Student-Athlete Experience Committee received an update from staff regarding the NCAA Division I Football Oversight Committee's recommendation to the NCAA Division I Council to adopt temporary legislation to permit institutions to increase the weekly limit on out-of-season countable athletically related activities. The Student-Athlete Experience Committee acknowledged that similar requests for sports other than football and basketball may be forthcoming. Additionally, the Student-Athlete Experience Committee noted the potential negative effect on student-athlete time demands.
