

REPORT OF THE NCAA DIVISION I STUDENT-ATHLETE EXPERIENCE COMMITTEE FEBRUARY 8, 2021, VIDEOCONFERENCE

ACTION ITEMS.

INFORMATIONAL ITEMS.

1. Temporary COVID-19 recruiting dead period/recruiting calendars. The NCAA Division I Student-Athlete Experience Committee indicated its preference that a decision on the current temporary COVID-19 recruiting dead period be made no earlier than the NCAA Division I Council meeting in March 2021 when more information will be available (e.g., positive case rates, vaccination rates, additional or expiring federal and local mandates). While the committee noted the importance of returning to normal recruiting activities, the committee would not be supportive of an immediate decision to allow the temporary COVID-19 recruiting dead period to expire on April 15, 2021, due to the uncertain state of the COVID-19 pandemic.

2. Division I Council referrals.

- a. NCAA Division I Presidential Forum Sustainability Review Short-Term Sustainability Issues. The committee received an update from staff regarding the committee's engagement in the NCAA Division I Presidential Forum's ongoing review to enhance the sustainability of NCAA Division I.
- b. COVID-19: Recruiting review. The committee received an update from staff about a holistic recruiting review that is planned for spring 2021. The committee will review recruiting legislation and leveraging of virtual tools (e.g., off-campus recruiting, campus visits, virtual recruiting restrictions, recruiting calendars) that were referred to the committee from the NCAA Division I Presidential Forum Sustainability Review.
