INFORMATIONAL ITEMS.

1. **NCAA Division I Preenrollment Amateurism Certification Committee.** The NCAA Student-Athlete Experience Committee (SAEC) reviewed and approved the 2024-25 preenrollment amateurism certification policies and procedures.
2. **Baseball – review composition of baseball legislative review subgroup.** The SAEC reviewed and supported the proposed composition of the baseball legislative review subgroup. The proposed composition will be presented to the NCAA Division I Council Coordination Committee for approval.
3. **Volleyball – American Volleyball Coaches Association (AVCA) – preseason showcase.** The SAEC continued to review a request to allow the AVCA to host a preseason showcase before the first permissible date of competition in women’s volleyball that will allow participating institutions to begin preseason practice seventeen days before the event. The committee will continue consideration during its March meeting.
4. **Transfer issues – undergraduate four-year transfers.** SAEC received an update regarding the NCAA Division I Board of Directors charge for staff and appropriate committees to develop legislation and/or policy modifications.
