

# REPORT OF THE NCAA DIVISION I STUDENT-ATHLETE EXPERIENCE COMMITTEE MARCH 1, 2021 VIDEOCONFERENCE

### ACTION ITEMS.

#### INFORMATIONAL ITEMS.

- 1. Temporary COVID-19 recruiting dead period/recruiting calendars. The NCAA Division I Student-Athlete Experience Committee discussed the creation of a uniform recruiting model until August 1, 2021, for all sports following the conclusion of the temporary COVID-19 recruiting dead period. The committee developed two models for a modified quiet period following the conclusion of the temporary COVID-19 dead period and requested feedback on each model from the NCAA Division I Football Oversight Committee, NCAA Division I Legislative Committee, NCAA Division I Men's Basketball Oversight Committee, NCAA Division I Women's Basketball Oversight Committee and NCAA Division I Student-Athlete Advisory Committee. After receiving feedback from the standing committees, the Student-Athlete Experience Committee will provide its recommendation to the NCAA Division I Council for review during its March 17 meeting.
- 2. NCAA Division I Presidential Forum Sustainability Review.
  - **a. Student-athlete financial aid.** The committee recommended extending the March 30, 2020, Council Action to permit institutions to provide institutional athletics aid using the NCAA Student Assistance Fund to student-athletes provided an additional year of athletics eligibility during the 2021-22 academic year.
  - **b. Maximum contest and dates of competition limitations.** The committee did not support a short-term review of the maximum contest and dates of competition limitations and noted the potential negative impact on the student-athlete experience that could result if maximum contest limits and dates of competition are reduced.
