

REPORT OF THE NCAA DIVISION I STUDENT-ATHLETE EXPERIENCE COMMITTEE MARCH 8, 2021, VIDEOCONFERENCE

ACTION ITEMS.

- 1. 2021 spring out-of-season activities. The NCAA Division I Student-Athlete Experience Committee recommended that the NCAA Division I Council approve a waiver to permit institutions to increase the week limit on out-of-season countable athletically related activities from eight to ten hours in sports other than football and basketball beginning on March 22 and concluding the week prior to the start of an institution's final exam period for the 2021 spring term. Specifically, the increase in two additional hours of nonphysical skill instruction may be used for film review and team meetings only. The committee noted that this recommendation provides additional opportunities for student-athletes to engage in activities with their teams outside the playing season while the COVID-19 pandemic continues to restrict their normal activities on campus.
- 2. Temporary COVID-19 recruiting dead period/recruiting calendars. The Student-Athlete Experience Committee recommended that the Council commit to the return of certain recruiting activities beginning June 1, 2021, following the conclusion of the current temporary COVID-19 recruiting dead period. The Student-Athlete Experience Committee will continue to refine its recommendations based on feedback from and collaboration with the standing committees and the NCAA Division I Student-Athlete Advisory Committee as appropriate.

INFORMATIONAL ITEMS.

- 1. NCAA Division I Presidential Forum Sustainability Review: Membership Requirements. The Student-Athlete Experience Committee supported the extension of the May 6, 2020, NCAA Division I Council Coordination Committee blanket waiver to allow institutions to provide less than the legislated minimum institutional financial aid for the 2021-22 academic year. The Student-Athlete Experience Committee supported including the membership minimum financial aid requirements in a long-term sustainability review.
- 2. Student-Athlete Experience Committee vacancies. The committee discussed the pending non-Council member vacancy and provided feedback regarding the preferred candidate experience, perspective and position.
- 3. Report of the March 1 Student-Athlete Experience Committee videoconference. The committee approved the report of its March 1 videoconference.
