**INFORMATIONAL ITEMS.**

1. **Institutional official visit and roster limit – review baseball membership survey.** The NCAA Division I Student-Athlete Experience Committee (SAEC) reviewed survey results from the NCAA Division I baseball membership related to a request to codify the blanket waivers increasing the institutional official-visit limit and the roster limit. The committee noted the complexity and interconnectedness of many of the baseball-specific rules and the difficulty in considering separate legislative requests. Therefore, the committee requested staff develop recommendations for consideration at a future meeting regarding a potential comprehensive review of baseball-specific legislation (e.g., institutional official visits, roster and counter limits in baseball, midyear transfers, financial aid requirements), which includes collaboration with baseball stakeholders and involvement of baseball student-athletes.

To maintain consistency while a comprehensive review is considered, the committee supported renewing the blanket waivers for institutional official visit, counter and roster limits during the 2024-25 academic year.

2. **NCAA Division I Committee for Legislative Relief – blanket waiver request – travel day as a day off.** The SAEC reviewed and provided feedback to the NCAA Division I Committee for Legislative Relief. The SAEC did not support the blanket waiver request at this time.
