**INFORMATIONAL ITEMS.**

1. **Update on actions taken by the NCAA Division I Women's Basketball Oversight Committee Administrative Subcommittee.** The Women's Basketball Oversight Committee received an update on the actions taken by the Administrative Subcommittee, including feedback on a request to permit noncoaching staff members to engage in limited coaching activities, initial feedback on the temporary recruiting dead period and 2020 fall recruiting calendar and recommendations for vacancy on the NCAA Division I Women's Basketball Competition Committee.
2. **Feedback on the temporary recruiting dead period and 2020 fall recruiting calendar.** The oversight committee provided feedback on the temporary recruiting dead period, which currently goes through August 31. The committee expressed support for extending the temporary recruiting dead period through October 31, 2020.
3. **Feedback on requests to permit noncoaching staff members to engage in limited coaching activities.** The oversight committee discussed these membership requests and expressed general support for noncoaching staff members participating in coaching and practice activities through at least the conclusion of preseason practice. The committee will continue to discuss the concepts and take a formal position on a future videoconference.
4. **NCAA initiatives to advance racial equity.** The oversight committee received an update on the formation of a student-athlete engagement group in women's basketball as well as the review of the use of standardized test scores as part of NCAA Division I initial-eligibility requirements.
