

## REPORT OF THE NCAA DIVISION I WOMEN'S BASKETBALL OVERSIGHT COMMITTEE ADMINISTRATIVE COMMITTEE AUGUST 1, 2025, VIDEOCONFERENCE

#### ACTION ITEMS.

#### INFORMATIONAL ITEMS.

- Amendments to the NCAA Division I Women's Basketball Recruiting Calendar. The Division I Women's Basketball Oversight Committee Administrative Committee reviewed the recommendations from the Women's Basketball Legislative Subcommittee to amend the Division I women's basketball recruiting calendar for the 2025-26 academic year. Additionally, the Administrative Committee focused on the April evaluation period specific to the 2026-27 academic year.
  - Amendment to the NCAA Division I Women's Basketball Recruiting Calendar Dead Period the Tuesday prior to Father's Day. The Administrative Committee amended the Division I women's basketball recruiting calendar to convert the dead period on Tuesday prior to Father's Day to a quiet period. This is effective immediately for application to the June 2026 scholastic evaluation period.
  - Amendment to the NCAA Division I Women's Basketball Recruiting Calendar Second July Evaluation Period. The Administrative Committee amended the Division I women's basketball recruiting calendar to shift the second July nonscholastic evaluation period from the third week to the fourth week of July. This is effective immediately for the July 2026 nonscholastic evaluation period.
  - Amendment to the NCAA Division I Women's Basketball Recruiting Calendar April Evaluation Period. The Administrative Committee amended the Division I women's basketball recruiting calendar to shift the April nonscholastic evaluation period to the last full weekend in April (Friday through Sunday), with the day immediately prior to the evaluation period and the day immediately after the evaluation period to be dead periods. This is effective for application to the April 2027 nonscholastic evaluation period.
- **Update from the NCAA Division I Decision-Making Working Group.** The Administrative Committee received an update on the ongoing work of the Division I Decision-Making Working Group. The NCAA Division I Board of Directors is expected to take action on the working group's recommendations at its August 5 meeting.
