



**REPORT OF THE NCAA DIVISION I WOMEN'S BASKETBALL
OVERSIGHT COMMITTEE
JANUARY 22, 2021, VIDEOCONFERENCE**

INFORMATIONAL ITEMS.

1. **NCAA vice president of women's basketball update.** The NCAA Division I Women's Basketball Oversight Committee received an overview of the 2021 regular season, including games completed, postponed or cancelled as well as season cancellations and an update on composition of the Division I Women's Basketball Committee.
2. **Update on the 2021 NCAA Division I Women's Basketball Championship.** The WBOC received an update on the plans for the 2021 NCAA Division I Women's Basketball Championship, including planning for one geographic area and the game schedule. The semifinals and national championship will remain on established dates of Friday, April 2 and Sunday, April 4, respectively. Additionally, the WBOC received an update on the COVID-19 impact on 2021 championship policies, including championship eligibility requirements, an increase in the team travel party and selection, seeding and bracketing policies and procedures. Finally, the WBOC received an update on the social media plan for coverage of women's basketball.
3. **NCAA women's basketball officiating update.** The WBOC received an officiating update, including the COVID-19 impact on officials as Tier 1 individuals, NCAA eligibility requirements for officials, the officials evaluation process and progress on strategic plan initiatives.
4. **Request from Southeastern Conference on individual associated with a prospective student-athlete and virtual recruiting flexibility.** The WBOC received an update on a request from the Southeastern Conference that the NCAA Division I Council remove Division I Proposal No. 2019-25 from the table and adopt it for FBS football as a result of the virtual recruiting flexibility granted as a result of COVID-19. The WBOC will continue discussing the issue on a future videoconference.
