



REPORT OF THE NCAA DIVISION I
MEN'S AND WOMEN'S BASKETBALL OVERSIGHT COMMITTEES
NOVEMBER 13, 2025, JOINT VIDEOCONFERENCE

ACTION ITEMS.

- **Legislative item.**
 - **Men's and Women's Basketball – Notification of Transfer – Undergraduate Student-Athletes - Reduce from 30 Days to 15 Days.**

Recommendation. The NCAA Division I Men's and Women's Basketball Oversight Committees introduced legislation to modify the notification of transfer window in men's and women's basketball to reduce the duration of the notification of transfer window for undergraduate four-year college transfer student-athletes from 30 days to 15 days. The oversight committees request the Division I Cabinet adopt the proposed change as expedited legislation at its January 14, 2026, meeting.

- (1) Effective date. Immediate.
- (2) Rationale. The recommendation to reduce the notification of transfer window from 30 days to 15 days for undergraduate four-year college transfer men's and women's basketball student-athletes provides student-athletes and coaches more certainty on roster stability and management. The committees reviewed recent transfer data in men's and women's basketball, which demonstrated most undergraduate basketball student-athletes enter the NCAA Transfer Portal within the first two weeks of the window opening. Reducing the notification of transfer window supports roster retention and provides transfer student-athletes additional time to complete transfer requirements (e.g., applications, transfer credit evaluation, summer school enrollment) to fully participate in summer athletics activities at their new institution.
- (3) Estimated budget impact. Varies by institution based on time recruiting off campus.
- (4) Student-athlete impact. The proposal provides more certainty around roster stability, especially during postseason competition. The recommendation also provides undergraduate transfer student-athletes more time to address academic requirements prior to participation at their new institution.

INFORMATIONAL ITEMS.

1. **Referral from the Division I Cabinet on the use of commercial trademarks or logos on uniforms, apparel and equipment.** The Division I Men's and Women's Basketball Oversight Committees received an update on Division I Proposal No. 2025-35, which would permit including additional trademarks and corporate logos on a student-athlete's uniform, apparel and equipment, playing surfaces and officials' uniforms during non-NCAA

championship competition. The NCAA Division I Men's and Women's Basketball Playing Rules Subcommittees will recommend the following to the Division I Cabinet at its December 1, 2025, meeting: (a) permit a maximum of two commercial or nonprofit logos, not to exceed four square inches, on the game jersey, game shorts, undershirts, undergarments, headbands, wristbands, socks or sleeves (the limit applies to all apparel items worn by a student-athlete in total); (b) retain current rule for commercial logos on playing surfaces and remove restrictions on commercial logos outside the playing surface; and (c) permit one commercial or nonprofit logo, not to exceed four square inches, on the upper left front of the officials' shirt. If adopted, these modifications would be effective August 1, 2026.

2. **NCAA Division I men's and women's basketball future tournament considerations.** The oversight committees received an update on NCAA Division I men's and women's basketball future tournament considerations.
3. **Legal affairs update.** The oversight committees received an update from the NCAA office of legal affairs.
4. **NCAA Division I Men's and Women's Basketball Oversight Committees' October 7 joint meeting report.** The oversight committees reviewed and approved the October 7 joint meeting report.
5. **Initial discussion on legislative topics.** Due to time constraints, the oversight committee will address this agenda item at its next meeting.
6. **Other business.** The oversight committees received an update that family travel stipends for the NCAA Division I men's and women's basketball championships will be expanded to encompass the regional rounds. Additionally, the oversight committees received an update from the staff on World Basketball Day initiatives, which will occur on December 21, 2025.
7. **Future meeting schedule.***
 - June 1-2, 2026 – in-person meeting in Indianapolis, IN.
 - October 5-6, 2026 – in-person meeting in Indianapolis, IN.
