MEN'S AND WOMEN'S BASKETBALL OVERSIGHT COMMITTEES
OCTOBER 8, 2024, JOINT MEETING

INFORMATIONAL ITEMS.

1. Review of legislative proposals.

- **NCAA Division I Proposal No. 2024-50: Playing and Practice Seasons – Basketball – First Permissible Contest Date and 22-Week Playing Season.** The NCAA Division I Men's and Women's Basketball Oversight Committees discussed Proposal No. 2024-50 and provided updates on individual committee action and discussion taken on the proposal. Specifically, the Women's Basketball Oversight Committee adopted the proposal for women's basketball during its August 20, 2024, videoconference and the Men's Basketball Oversight Committee amended Proposal No. 2024-50 to a Monday start date and adopted the proposal as amended in men's basketball during its October 7-8, 2024, meeting. Both oversight committees also supported and adopted a consistent 22-week playing season.
- **NCAA Division I Proposal No. 2024-46: Recruiting – Notification of Transfer Windows – Reduce from 45 Days to 30 Days – Basketball and Football.** The Men's and Women's Basketball Oversight Committees discussed Proposal No. 2024-46 and reaffirmed their support to reduce the notification of transfer window from 45 days to 30 days. Under this proposal, the notification to transfer windows opens the day after the conclusion of the second round of the NCAA Division I Men's and Women's Basketball Championships.

2. Update on the proposed new signing model. The oversight committees shared the recommendations they made to the NCAA Division I Council for the proposed new signing model. Specifically, the oversight committees noted from their individual meetings on October 7-8, they do not support any changes to the spring signing period at this time. The oversight committees will continue to monitor and discuss the need for any changes to the signing model in the future. Finally, the council is expected to vote on the new signing model during its October 8-9, 2024, meeting.

3. Multiple-team event discussion. The oversight committees took action to approve a plan and timeline for conducting a comprehensive review of the MTE legislation. Additionally, the oversight committees directed the staff to approve a legislative relief blanket waiver of the MTE legislation for the 2024-2025 season. The blanket waiver provides relief of the one team per conference and participation in one event during a four-year period criterion, provided the institution's participation in the MTE meets all other MTE criteria. The oversight committees agreed to discuss the timeline for anticipated completion of the MTE review and its impact on scheduling for the 2025-26 season in future oversight committee discussions, including whether to extend the blanket waiver for 2025-26.

4. **Review of logos during competition.** The oversight committees reviewed the basketball playing rules, legislation and basketball championship policies for logos on player uniforms and the basketball court.
5. **June 2024 Scholastic Events Summit update.** The oversight committees received an update from the June 2024 Scholastic Events Summit on August 28. The Summit included individuals from the National Federation of State High School Association, National High School Basketball Coaches Association, National Association of Basketball Coaches, Women's Basketball Coaches Association, NCAA, Men's Basketball Oversight Committee and the Women's Basketball Oversight Committee. The group will reconvene next fall to review and evaluate the 2025 June scholastic recruiting period.
6. **NCAA Division I Men's and Women's Basketball Oversight Committees' September 4 videoconference report.** The oversight committees reviewed and approved the September 4 videoconference joint meeting report.
7. **Other business.** The oversight committees received an update from the staff on World Basketball Day, which occurs on December 21, 2024.
