

# REPORT OF THE NCAA DIVISION I MEN'S AND WOMEN'S BASKETBALL OVERSIGHT COMMITTEES OCTOBER 7, 2025, JOINT MEETING

## **ACTION ITEMS.**

## INFORMATIONAL ITEMS.

- 1. Initial discussion on the notification of transfer windows for NCAA Division I men's and women's basketball. The NCAA Division I Men's and Women's Basketball Oversight Committees conducted an initial discussion on possible amendments to the notification of transfer windows for men's and women's basketball. Currently, a 30-day notification of transfer window opens the day after the end of the second round of the Division I basketball championship. The oversight committees received historical background information on the notification of transfer legislation, proposals and amendments. Additionally, the oversight committees received updates on proposed legislation from the NCAA Division I Football Subdivision and Championship Subdivision Oversight Committees, and the oversight committees addressed factors relevant to the sports of men's and women's basketball. The discussion centered on the opening of the transfer window, the length of the window, and the impact of the transfer window on NCAA postseason competition and the academic calendar. Additionally, the oversight committees raised concerns regarding how the timing of the transfer window will impact recruiting periods and the effect on potential tampering of prospective student-athletes. The oversight committees will continue to solicit student-athlete and coach feedback and introduce legislation in an upcoming legislative cycle.
- 2. NCAA Division I men's and women's basketball future tournament considerations. The oversight committees received an update on NCAA Division I men's and women's basketball future tournament considerations.
- 3. Update on NCAA Division I Proposal No. 2025-27 Division Membership -- Revenue Guarantee -- Revenue Distribution Formula -- Basketball Performance Funds -- Final Four Performance Units. Due to time constraints, the oversight committees did not address this agenda item. However, a vote of the Division I membership will occur on this proposal during the NCAA Division I Business Session at the 2026 NCAA Convention. The Division I Business Session will begin at 2:30 p.m. Eastern time, Wednesday, January 14.
