ACTION ITEMS.

1. Legislative items.

2. Nonlegislative items.

- **Sport and rules committee appointments.** Ratify the following sport and playing rules committee appointments, effective September 1, 2019, unless specified otherwise.
 - a. **Women's soccer.** Appoint **Chad Markuson**, deputy director of athletics, Minnesota State University Moorhead, to replace Lewis Theobald, head women's soccer coach, University of Central Missouri, due to term expiration. *[Note: Margaret McGraw, associate director of athletics and senior woman administrator, Ouachita Baptist University, had previously been selected to replace Mr. Theobald but has since left Division II.]*
 - b. **Men's and women's soccer rules (two immediate vacancies).** Appoint **Anthony McCall**, head men's soccer coach, Regis University (Colorado), to replace Alex Balog, head men's soccer coach, Montana State University Billings, who has left Division II; appoint **Hope Clark**, associate director of athletics/senior woman administrator, Young Harris College, to replace Sarah Rountree, assistant commissioner, Conference Carolinas, who resigned her position.
 - c. **Men's and women's tennis.** Appoint **TJ Budd**, assistant director of athletics/communications, Palm Beach Atlantic University, to replace Chi Ly, head men's and women's tennis coach, Palm Beach Atlantic University, due to term expiration. *[Note: Kelly Elliott, assistant commissioner and senior woman administrator at the Southern Intercollegiate Athletic Association, had originally been selected to replace Mr. Ly but declined the appointment.]*
 - d. **Men's and women's track and field rules committee (immediate vacancy).** Appoint **Bridgette Johnson-Tetteh**, associate commissioner, Great Northwest Athletic Conference, to replace Larry Mortensen, director of athletics, Adams State University, who retired in May.
 - e. **Women's volleyball rules (immediate vacancy).** Appoint **Tiffany McCampbell**, associate director of athletics/external relations, Colorado School of Mines, to replace Jennifer Flowers, assistant commissioner, Northern Sun Intercollegiate Conference, who has left Division II.
