INFORMATIONAL ITEMS.

1. **Discussion regarding NCAA Division II Bylaw 14.5.5.1 (general rule).** The NCAA Division II Legislation Committee reviewed and provided feedback on three concepts that are being considered by the NCAA Division II Academic Requirements Committee regarding Bylaw 14.5.5.1 (general rule). Further, the committee provided feedback on Bylaw 14.4.3.2.1 (application of rule to transfer student) and whether the legislation would still be necessary with the new transfer standard(s).

The committee also provided feedback on what the new standard should be if a transfer student-athlete is unable to meet the new transfer standard(s). Finally, the committee provided feedback on the June 15 written notification of transfer deadline and whether a transfer student-athlete should be required to provide written notification of transfer by June 15 prior to being immediately eligible under the new transfer standard(s). The committee agreed that the June 15 date may no longer be appropriate, however, the committee agreed that a transfer student-athlete should be required to provide written notification of transfer by a certain deadline. The committee will continue its discussion and provide final feedback during its March 26-27, 2024, in-person meeting.
