

# REPORT OF THE NCAA DIVISION III ADVISORY COUNCIL APRIL 25, 2022, VIDEOCONFERENCE

- **1. Welcome and roster.** The videoconference commenced at 2 p.m. Eastern.
- **2. Review of April 7, 2022, videoconference report.** The Advisory Council reviewed the report and had one edit.
- 3. Review of Division III bylaws, policies and initiatives chart. A spokesperson for each topic area (i.e., legislative concepts, organization, championships and budget, membership), the Division III Student-Athlete Advisory Committee (SAAC), the Division III Conference Commissioners Association (DIIICA) and the National Association of Division III Athletics Administrators (NADIIIA) reported on recent work within their respective groups related to the bylaws, policies and initiatives chart. These reports highlighted the open communication across the governance committees, Councils, external constituent groups and national office staff.

Advisory Council members provided the following feedback:

- Requested the Division III Interpretations and Legislation Committee (ILC) consider soliciting feedback on recommended playing and practice seasons models from various coaches' associations prior to making a formal recommendation to the Division III Management Council.
- Requested the Division III Championships Committee and Strategic Planning and Finance Committee examine the 2022 Membership Survey findings regarding championships access ratios.
- Agreed with the request from NADIIIAA that the composition and charge of the NCAA
  Playing Rules Oversight Panel be examined, and consideration be given to equal
  representation from each division. It also supported a policy change to allow for rules to
  be established on a division-specific basis unless there is a health and safety component.
- **4. Future meetings.** The chair noted that the Advisory Council's next videoconference is Wednesday May 25, noon Eastern.
- **5. Adjournment.** The committee adjourned at 3:02 p.m. Eastern.
