

REPORT OF THE NCAA DIVISION III CHAMPIONSHIPS COMMITTEE AUGUST 29, 2024, VIDEOCONFERENCE

ACTION ITEMS.

INFORMATIONAL ITEMS.

- **1. Welcome and announcements.** Division III Championships Committee Chair Karen Tessmer welcomed the group and previewed the agenda.
- **2. Future Division III championship sites.** The committee reviewed and approved recommendations from sport committees for championship host sites in all sports for the 2026-28 cycle. The committee noted these sites provide an excellent mix of proven and new hosts and a breadth of regional diversity that will offer student-athletes an exemplary postseason experience throughout the length of the cycle. The approved sites are confidential until the official announcement through an NCAA news release on October 2.
- 3. Sport committee reports.
 - a. Men's golf.
 - Legislative amendment. The committee reviewed the recommendation to amend NCAA Bylaw 16.8.1.1 (practice) for men's golf to increase the mileage restriction and provide more flexibility for teams to practice at different courses and in different areas of the region. After discussion, the committee asked that the issue be referred to the Division III Interpretations and Legislation Committee (ILC) to review both the merits of the proposal as well as whether it should be processed through the governance structure as Convention legislation or as a membership-sponsored proposal. (The committee also noted that the earliest the proposal could be addressed is at the 2026 Convention, as the deadline to submit legislation for the 2025 Convention has passed.) Further, while the recommendation came from the men's golf committee, the Championships Committee is asking the ILC to consider whether the recommendation should apply to all sports.

b. Women's lacrosse.

(1) Automatic qualification. The committee approved that the following 31 conferences be granted automatic qualification to the 2025 NCAA Division III Women's Lacrosse Championship: Atlantic East Conference; Centennial Conference; College Conference of Illinois and Wisconsin; Commonwealth Coast Conference; Empire 8; Great Northeast

(2) Future championship sites. The committee also noted as information that the women's lacrosse committee is working to finalize site recommendations for the 2025 and 2026 championships and expects to seek approval later this fall.

c. Men's and women's soccer.

• Championships date formula. The Championships Committee noted the joint recommendation from the soccer committees to change the date formula for the Division III Men's and Women's Soccer Championships by moving the date one week later to align with the other divisions, provide more rest and recovery during the regular season, and improve the overall experience of the soccer student-athletes. Committee members acknowledged the results from a survey sent to Division III soccer coaches, athletics directors, athletic trainers and commissioners. The committee will review those results and discuss the proposal in more detail during the committee's September in-person meeting.

d. Softball.

• Automatic qualification. - (1) Automatic qualification (men's tennis). - (2) Automatic qualification (women's tennis). - (3) AQ deadline. The committee reviewed but ultimately did not support the recommendation to amend Bylaw 31.3.3.1-(a) to require all tennis conference championships to be completed not later than 3 p.m. Eastern time on selection day (rather than the currently legislated 6 p.m. local time). The committee cited the fact that the time slots at tennis facilities are often not under the conference's control, which would complicate a deadline adjustment. While they did not support the proposal, committee members urged communication with commissioners to make every effort to complete their tournaments in a timely manner to help the tennis committees do their work.
- (4) Individual alternate increase. The committee supported the tennis committees' policy recommendation to increase the number of selected alternates for the individual championships the singles alternates from four to eight and the doubles alternates from four to six. This provides flexibility to offer an opportunity to as many participants as possible. Additionally, this decreases the possibility of a bye in the first round of individual competition. Division III does not require onsite alternates, so there is no budget impact.
- (5) Tennis playing rules. The committee reviewed the tennis committees' decision to adopt the seven-point scoring format (clinch-clinch) for the 2025 championships on a one-year pilot basis. Championships Committee members, while acknowledging they do not have jurisdiction over playing rules, nonetheless expressed concern with how this decision was reached and agreed to discuss this further during the September inperson meeting.
