

REPORT OF THE NCAA DIVISION III CONVENTION PLANNING SUBCOMMITTEE SEPTEMBER 8, 2025, VIDEOCONFERENCE

- 1. Welcome and review roster. The subcommittee commenced business at 1 p.m. Eastern time. The chair welcomed Corey Borchardt, Upper Midwest Athletic Conference, as the new representative for the Division III Commissioners Association.
- **2. Approval of June 25, 2025, videoconference report**. The subcommittee approved the report from its June 25, 2025, videoconference.
- 3. Convention Management updates. The subcommittee was informed that the registration for the Convention will open Sept. 10. The early bird registration rate remains at \$325. Hotel rates are posted on ncaa.org. Following the conclusion of the Convention, bus transportation will be available only to Ronald Reagan International Airport.
- 4. **Division III Education Session topics.** The subcommittee reviewed and endorsed the titles and descriptions for the three Division III convention education sessions. The subcommittee also provided suggestions for possible speakers for the session concerning the use of AI in a Division III athletics department.
- 5. Division III Governance Session and Delegates Schedule. The subcommittee reviewed and discussed the Division III governance-related sessions and the Division III delegates' schedule. Staff highlighted the following sessions for the subcommittee: the Student Immersion Program, athletics direct report professional development programming, chancellors/presidents forum, program for new athletics directors and student-athlete programming.
