1. WELCOME AND ANNOUNCEMENTS.

January 13 Management Council. The meeting was called to order at 8:02 a.m. Eastern time, January 13. The chair, Jason Verdugo, welcomed the council and reviewed guest presenters and key agenda items.

(a) 2025-26 Budget-to-Actuals.

Management and Presidents Councils. The councils reviewed the budget-to-actuals for 2025-26.

(b) Future Budget Projections.

Management and Presidents Councils. The councils revisited the projections they reviewed during their fall meetings, noting that the new FY26 budget is approximately \$1.5 million more than FY25.

(c) Membership Dues Assessment.

Management and Presidents Councils. The councils approved continuing to pause the Division III membership dues assessment (\$1,100 for institutions and \$550 for conferences) for FY27. The councils previously approved pausing the dues assessment for FY25 and FY26 based on the division's reserves coupled with the tight campus and conference budgets. The SPFC believes the recommendation to continue the pause is prudent, particularly given the upcoming analysis of Division III that the Presidents Council authorized conducting in the coming months, as well as the ongoing financial uncertainty surrounding higher education. While continuing the pause means the division will sacrifice approximately \$500,000 in annual revenue, the impact on the membership is meaningful, and the loss of revenue does not compromise the division's ability to provide resources and programming to benefit

its members. The SPFC and councils will re-evaluate whether to continue the pause beyond FY27.

Per a recommendation from the committee, the council approved in concept noncontroversial legislation within Bylaw 32.1.1 to allow two exceptions to the restriction on public disclosure of information during an infractions case. The first exception permits the parties to an infractions case to respond to divulged information related to an ongoing infractions case by confirming, correcting, or denying the information. The second exception permits the NCAA national office to

share information if there is an immediate need to prevent harm or to address a potential ongoing violation.

(5) **Interpretations and Legislation Committee (ILC).**

Noncontroversial Legislation. Eligibility – Criteria for Determining Season of Eligibility – Participation in Organized Competition Before Initial Collegiate Enrollment – Elimination of Academic Year of Residence.

Management Council. Per a recommendation from the committee, the council approved in concept noncontroversial legislation eliminating Bylaw 14.2.4.4.1 (Academic Year of Residence) as a condition for student-athletes who participate in organized competition after delaying their initial full-time collegiate enrollment.

Currently, prospective student-athletes who delay their initial full-time collegiate enrollment and continue to participate in organized competition after the legislated one-year grace period (a) lose a season of eligibility for each 12 months in which they continue to participate; and (b) must sit out from competition during their initial year of residence at a Division III institution. During that time, however, individuals are still eligible to practice, which means they must decide whether they use a season of participation by practicing when they are not permitted to compete. Loss of a season is an appropriate condition for when an individual delays their initial collegiate enrollment past the grace period because it negates any competitive advantage gained. There is no need to also require the student to serve an academic year of residence during their initial year in Division III, prohibiting them from being immediately eligible for competition.

(9) Student-Athlete Reinstatement Committee (SAR).

Cross-Divisional Issues Policy Amendments.

Management Council. Per a recommendation from the committee, the council approved amendments to the Division III Committee on Student-Athlete Reinstatement Policies and Procedures (Cross-Divisional Issues Policy). For student-athletes that transfer from Division I or II to Division III, the amendment will clarify which division's bylaws and guidelines apply to the waiver or reinstatement request. As the result of the federation of the NCAA Committee on Student-Athlete Reinstatement, the Division III SAR believes the amendments eliminate confusion surrounding cross-divisional issues.

The council also received an update on the committee's ongoing discussion of how to address reinstatement requests involving student-athletes who wager on intercollegiate athletics. The committee considered concepts including deferment and/or reduced penalties. The committee noted the importance of supporting student-athletes through harm reduction strategies and education. The committee will continue to review and discuss this topic during its spring meeting.

(3) Committee on Competitive Safeguards and Medical Aspects of Sports (CSMAS).

Management Council. The council reviewed the report from the committee's September meeting and received a verbal update from the December meeting. The committee has asked relevant playing rules bodies for sports that limit substitutions and/or reentry to allow exceptions for any student-athlete seeking timely medical evaluation and/or treatment of any condition with the potential to cause catastrophic injury or illness (including, but not limited to diabetes, sickle cell trait, asthma), as determined by the primary athletics health care provider. No action from the council was necessary.

The council also reviewed the new nonbinding Performance Technology Consensus Statements. The committee approved these during its December meeting. The statements resulted from the NCAA Summit on Performance Technologies in Collegiate Athletics. The statements provide the NCAA membership with recommendations for the responsible use of performance technologies.

4. 2026 NCAA CONVENTION LEGISLATION.

a. Review of Convention Logistics.

Management and Presidents Councils. Staff reviewed the delegates' schedule, the joint Management Council/Presidents Council/Student-Athlete Advisory Committee breakfast, the Issues Forum, the Presidents and Chancellors Forum, and the Division III Business Session. No action was necessary.

b. Review of Convention Official Notice.

Management and Presidents Councils. The councils reviewed the Official Notice, including updates on items in the blue pages. No action was necessary.

c. Review of Legislative Proposal Question and Answer Guide.

d. Review of Speaker Assignments.

e. Review of Parliamentary and Voting Procedures.

Management Council. The council reviewed the Convention Mootnicity and Related Parliamentary Issues document and recommended that the Presidents Council formally adopt it, noting that there are no mootnicity issues for any of the proposals.

5. NONCONTROVERSIAL LEGISLATION FOR THE 2027 NCAA CONVENTION.

Management Council. The council formally adopted in final legislative format the following noncontroversial legislative proposals:

- a. NC-2027-1 Association-Wide Committees – Rules Committees Without Championships Administration Responsibilities – Men’s and Women’s Ice Hockey Rules Committee Composition. Effective date: Immediate. Intent: To reduce the number of Division II representatives on the Division II and III Men's and Women's Ice Hockey Rules Committee from two to one (and thus reduce the total membership on the committee from nine to eight (six Division III members; one Division II member; one non-voting secretary-rules editor).
- b. NC 2027-2 Division III Committees – Exemption to the Current Compositional Requirements for NCAA Division III Management Council Assigned Committees and NCAA Division III Strategic Planning and Finance Committee. Effective date: Immediate. Intent: To clarify that an appointed position on a committee does not count for determining area or multisport conference representation; and that for the members of the NCAA Division III Strategic Planning and Finance Committee that are not appointed by position (at large members), there must be at least one representative from each Division III geographic area.

6. DIVISION III INITIATIVES AND UPDATES.

a. Division III Graduation Rates.

Management and Presidents Councils. The councils received a presentation of the most recent Division III graduation rates. Using the federal graduation rate, the councils noted higher rates for student-athletes within each demographic subgroup other than Black men. This finding is consistent across six years of mandatory data collection for Division III. The councils will continue discussing these findings at future meetings.

b. Championships Livestreaming.

Management Council. The council reviewed the results from the livestreaming of the 2025 fall Division III championships except football and women’s volleyball. The council noted that this is the second year that every fall championship was streamed (211 events). There was an 8% increase in total minutes watched compared to fall 2024.

c. Division III Branding and Promotions.

Management Council. The council received an update on the division's branding and promotions efforts, including events planned to recognize the 15th anniversary of the division's relationship with Special Olympics.

Management and Presidents Councils. The councils received an update regarding the narrowly focused analysis of the division that the Presidents Council approved in October. The goal of the analysis is to identify points of tension that currently exist with, but not limited to, the division's legislation, policies and decision making and to provide recommendations to resolve those issues for the membership to consider. The analysis will begin with the Presidents and Chancellors Forum and the Division III Issues Forum during the 2026 Convention. The Presidents Council will finalize the process to conduct the analysis at a future meeting.

e. Faculty Athletics Representative Advisory Group.

- (1) **Membership engagement.** The council was informed of the efforts being made to engage the membership, student-athletes, and additional elite athletics organizations.
- (2) **Athletic trainers.** The council was advised of SSI's efforts to collaborate with various national athletic trainer organizations. These efforts include monthly meetings focused on the creation of mentoring pipelines, team physician advocacy program, and a resource that provides examples of various health care delivery options.
