

REPORT OF THE NCAA DIVISION III MEMBERSHIP COMMITTEE SEPTEMBER 19, 2024, VIDEOCONFERENCE

- 1. Welcome and announcements. The committee commenced business at 1 p.m. Eastern.
- 2. Membership Committee roster and conflict of interest. Committee members were reminded of the NCAA Conflict of Interest Policy and proper procedures for recusal if a conflict of interest might arise. Committee members reviewed the roster and conflict of interest documentation.
- **3. Review policies and procedures.** The committee reviewed the policies and procedures documents.

- 5. Recommend position for 2025 Convention proposal. The committee recommended that Management Council take the following position on a membership-sponsored proposal under consideration for the Convention:
 - Division III Proposal Multisport Conference Membership Size Minimum Requirement. The committee recommended the council take a position of support for this proposal. Because this proposal aligns the multisport conference size requirement with the current automatic qualifier standard, it provides institutions and conferences with consistency and clarity. Additionally, it appropriately considers the geography of the division and allows for greater flexibility to conferences and institutions in more geographically isolated parts of the country. Corey Borchardt, Upper Midwest Athletic Conference and Chris Roekle, Coast-to-Coast Conference recused themselves.
- **6. Review 2025 Convention Question and Answer Guide.** The committee reviewed and provided the staff with feedback regarding the 2025 NCAA Convention Division III Legislative Proposals Question and Answer guide.
- 7. **Institutional Merger.** The committee reviewed additional documents detailing the merger of the University of Findlay (Division II) and Bluffton University (Division III) and will continue to monitor the status of the merger.
